**MAYOR MURPHY:** The Mayor discussed an upcoming festival in Sahaurita on April 23<sup>rd</sup> and mentioned the new road to Quail Creek is going well.

**PRESIDENT KENYON REPORT:** President Kenyon mentioned Goldschmidt Shupe will be available to talk to members after every BOR meeting. She also detailed upcoming forums and discussed the many standing committee's and other opportunities to become part of GVC. She also shared that Brad Richards has agreed to be the new treasurer on GVC after he is formally elected.

**TOM BEREZNEY REPORT:** Tom mentioned DOT is developing a list of road improvements. He gave details on sealing work on La Canada. He also mentioned contractors will be replacing missing fire hydrant blue reflectors.
