Commander Kenyon Report: The Commander gave details on recent special events as well as upcoming events, and number of patrol hours. He gave information on the next El Tour to be held in November.

President Kenyon Report: The President gave details on the many upcoming forums. She also gave an update on tapestry sales. She mentioned working on a list of needs for committee members and reaching out for help in getting new members. She also mentioned there will be no BOR

meetings during the summer and a plan for forums to be held in the summer. She also mentioned working on a 3-year strategic plan. She also welcomed Brad Richards as the new GVC treasurer.

Dick Roberts Report: Dick reported on a trip with the President and David to visit RTA and PAG. He gave details on a proposed half cent tax increase and the need to sell the idea to GV by proposing ideas for future projects where the money would benefit GV, including a possible light rail from Amado to the airport, and the mall, and also better transportation services to Tucson.
