**Call to Order:** President Kenyon called the meeting to order at 8:30am

**Approval of Minutes:** A motion was made and seconded to approve the March Minutes

**Approval of Financial Statement:** A motion was made and seconded to approve the Financial Statement.

**Supervisor Christy:** The Supervisor updated on his recent health issues. He also mentioned he was proud to present Jim Click with a presentation for his outstanding contributions to the community at the Board of Supervisors Meeting. The Supervisor also mentioned he was proud to announce four communities in GV were certified for wildfire preparedness. He further mentioned Chris Ackerly has been voted in as PC Treasurer. The Supervisor stated the primary property tax will be going up, while he will try to convince them otherwise, it seems imminent. He fielded questions on why it's going up, and he explained it is for new programs, and for the uncertainty of funding for migrants. He fielded questions on the jail issue as well as Federal vs County monies spend of the migrants.

On reporting for the Lt., he reported traffic stops, citations, incidents, and collisions. On reporting for SAV He reported man hours, incidents and scams, park patrols and house checks.

**President Kenyon:** President Kenyon reported a bill has gone unanimously to the Governor that will not allow HOA's to collect attorney fees, it was signed and now is in a waiting period to wait for remarks. She also updated on the First Responders Fair and where the monies donated will be going. David Showed a wonderful video of the Fair. The President also updated on the upcoming Monsoon Madness Forum to be held June 6 at CPAC. She further mentioned new upcoming projects, as well as a workshop on June 20th to get ideas on forums in the Fall. The President also encouraged everyone to attend the forum on the Reliability Project April 25 at the East Center. She also noted it is Volunteer Appreciation Month and GVC has logged 5500 volunteer hours.

**Tom Berezny:** Tom discussed RTA Next and mentioned and stated GV has no projects in the works. He also discussed the half cent sales tax for 30 additional projects. Tom also mentioned the road work needed at Encanto and Frontage and stated ADOT will not do it. PDOT is working with ADOT to get an encroachment permit to do the work.

Lastly Michelle gave an informative presentation of Digital Inclusion, Stating the point is for it to create competition, and to reach the unserved and underserved. She brought many helpful handouts.
